INFORMATION

1. Event reservations are on first come- first serve basis. A reservation is not confirmed until the full fee is received.
2. Payment is for use of the grounds only. The Wesley House cannot be used.
3. Alcohol is prohibited in all State Parks during normal operating hours (8am-sunset).
4. Rice may not be thrown, but birdseed and soap bubbles are expectable alternatives.
5. The event contact (whose signature is listed below) is responsible to ensure all clean up and removal of all decorations is completed to the satisfaction of Park staff. Set-up must be coordinated through the park office and occur on the day of the event. Break-downs should be immediately following the event or on the next morning. The park opens everyday at 8:00am and closes at sundown.
6. Electricity is available at certain locations on the park grounds.
7. Special arrangements must be coordinated with park staff (bands, dance floors, etc)
8. If a cancellation is required, a six-month written notice and your cash receipt must be received for a full refund.
9. The ceremony may begin before sunset. The event is to be over by 10:00pm, clean up to follow Gates will be locked at 11:00 pm.
10. No Vehicles, nor tents on the grass, 3- 10'x10' Free-standing Pop-up canopies will be allowed. Under no circumstances will large tents be allowed.
11. If using a coordinator/ caterer they must coordinate through the park office at least two weeks before the event.
12. No cancellations due to weather except in the event of a hurricane.
